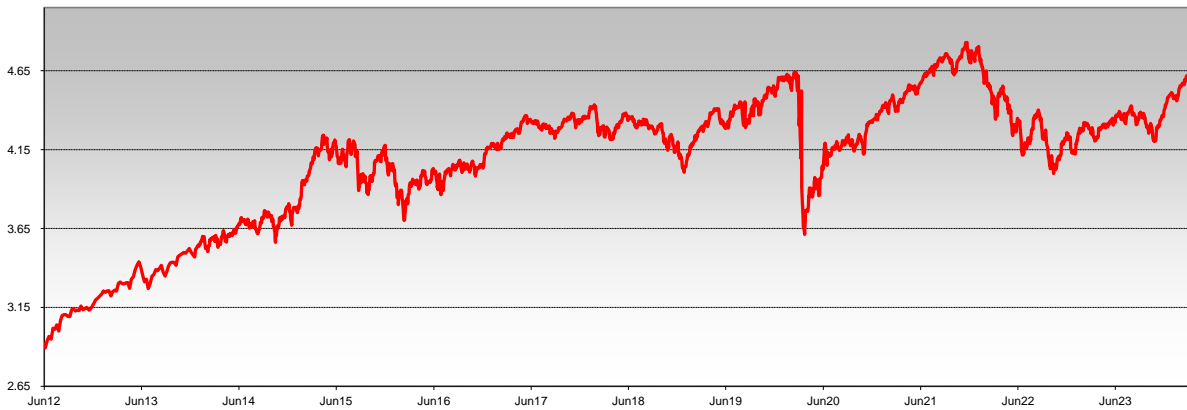

Investment Objectives

The Fund seeks to provide long-term total return expressed in euro by adopting a balanced investment strategy that invests in equities and fixed income securities. Exposure to fixed income and equity securities is achieved through HSBC Life Assurance (Malta) Ltd. unit-linked Funds ("HLM Funds"). These HLM Funds and their respective underlying funds may invest in financial derivatives, other financial instruments and engage in leverage which may result in the overall risk exposure of the underlying funds to exceed their total net assets. For operational purposes the underlying HLM Funds may hold a proportionately small amount of its holdings in cash. When replacing an underlying fund the HLM Fund may also retain all its holdings in cash for the short period required between receipt of settlement price and execution of the buy order.

Performance History in EUR (Bid Price)



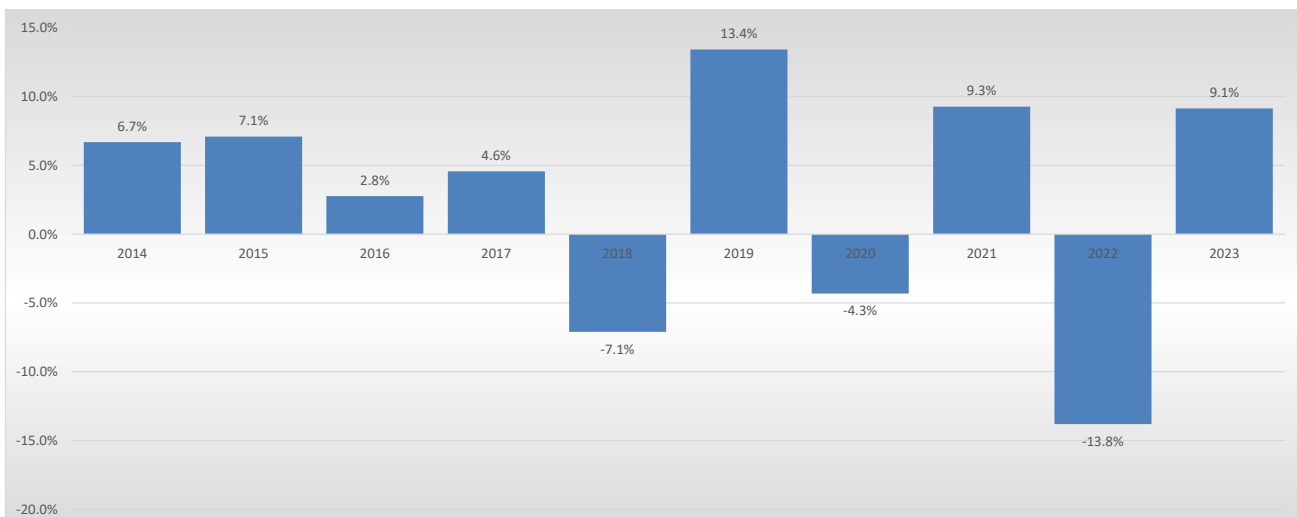
